- 3. Gross Profit was \$5101.00. Net Ordinary Income for the month was \$374.72. Lawful Purpose Expenditures were \$562.50.
- 4. We will staff meat raffles two times per month for the rest of 2013, then we will staff all the meat raffles starting in January. We are not making enough money to make donations to all of the sports that need help. We will re-address this decision in June 2014.
- 5. We have given \$14,000 so far this year; last year at this time we had given out \$13,000.
- 6. Sherry discussed different ways to decrease our payroll.
- 7. Pull tab sales are down this year compared to last year.
- 8. M/S/P (Tim/Teresa) to approve the Gambling Report.
- 9. Typical expenses each month include: rent, equipment, payroll, cost of games.

NEW BUSINESS:

- 1. The Xcel Energy "Dollars For Doing" checks (for volunteer hours) do not have a sport designated when we receive them. They do have the volunteer's name on the check. Unless we are notified about the donation coming in, we do not know which sport the money goes to. From now on, we will deposit the checks into our General Fund and then transfer the money to the sport when we are told which sport gets the donation. (If you know that you are getting a donation from Xcel, let us know.)
- 2. The website has been updated.
- 3. We will make a donation to Matt Eigen (same amount as last year) for work done on the website. This money will come from the General Fund.
